Minutes of January 22, 2016 Meeting

CASSAR Past President Jim Faulkinbury presented a historical overview of two flags. One flag surfaced before the Revolutionary War and the other just after the war.

The Taunton Flag was a flag of protest and petition, actually raised on "liberty poles" throughout the Thirteen Colonies and particularly in New England during the years prior to the outbreak of the Revolutionary War. It was one of the first flags to represent dissention amongst the Colonies. This flag was raised in the town of Taunton, Massachusetts as a symbol of the colonies' frustration and unwillingness to be persecuted.



French Alliance

In 1781 and 1782, in honor of the end of the American Revolutionary War and the help of France in that conflict, a special U.S. flag appeared called the French Alliance flag. It was to honor France for all the support it provided the new United States. France provided rifles, French troops and the French Navy to blockade the British Navy at the last major battle fought at Yorktown. Their support helped win the war. President Anderson announced that the nominations for Chapter officers were: Craig Anderson, President, Don Littlefield, Executive Vice President and Treasurer, Carl Ahlberg, Secretary, and Alan Brooking, Registrar. He called for a voice vote on the candidates and all votes were in favor with no dissenting votes.

President Anderson then asked Jim Faulkinbury to come forward and swear in the 2016 officers.

After the new officers were sworn in President Anderson wished everyone a Happy New Year and thanked the membership for allowing him to serve as President during 2015. He said it was an enjoyable experience and he is looking forward to 2016. He then shared some of the chapter's accomplishments for 2015:

The School Guard gave 5th Grade Living History presentations in 14 schools in the greater Sacramento area during 2015 coordinated by our Color Guard Commander, Russ Kaiser, and participants Tom Chilton, Jim Faulkinbury, Alan Brooking, Ernie Garcia, and DAR member Helena Hurst. This program is a one-of-a-kind program in the SAR, and is looked upon by the National Society as a "Best Practice" in educational outreach programs. President Anderson pointed out our chapter has a lot to be proud of through the efforts of these compatriots.

Our Color Guard, under the command of Russ Kaiser, played an important role in our chapter's visibility by participating in local patriotic events: Memorial Day Ceremonies Sylvan Cemetery; Founders Day ceremony at the San Francisco Presidio; 4th of July Parade, Carmichael, CA.; CSSDAR meeting in Rancho Cordova, Sacramento Veterans Day Parade, and Wreaths Across America at the Sacramento Valley National Cemetery.

President Anderson then presented Russ Kaiser with the Distinguished Service Medal.

President Anderson pointed out our Chapter had 14 high schools and 2 universities participate in our 2015 JROTC/ ROTC program under the leadership of Roy Adkins; this program recognizes the outstanding cadets in their schools. Two years ago, our chapter's winner of the Enhanced JROTC program went on to win at the state and national level. This year, and at the request of the Program Chair, Roy Adkins, we approved some recognition enhancements to the program to encourage participation in the enhanced JROTC program. Last year, we had five entries.

President Anderson thanked the compatriots who served on the judging committee with Roy Adkins: Ronald Hollis, Glenn Cline, Mike Brady, Larry Guile, and Don Littlefield.

President Anderson then presented Roy Adkins with the Meritorious Service Medal

In 2015, our chapter had 19 school classrooms participate in the SAR Americanism Poster Contest under the leadership of Tom Chilton. It was only a few years ago that we were hard pressed to get any school involvement, but through Tom's hard work, this program has become a huge success. We plan **to grow this program during 2016 to include 26 classrooms.**

President Anderson presented Tom Chilton with a Certificate of Appreciation
To become an Eagle Scout requires a huge personal commitment of the scout, and our program is designed to recognize and honor that achievement. Our Eagle Scout recognition program under the leadership of Neil Zinn has presented Certificates of Achievement to 10 new Eagle Scouts this year.

Neil Zinn was not present to receive the Meritorious Service Medal.

During our Community Events Dinner in October, our Activities Chairman Ernie Garcia awarded SAR Law Enforcement Medals to representatives of the California Highway Patrol, Sacramento Sheriffs Office, and West Sacramento Police Department. As usual, he has done an outstanding job coordinating with area Law Enforcement Agencies making this function a success.

President Anderson also thanked three other members:

Jim Faulkinbury who provides invaluable service to the Chapter by being a NSSAR - CASSAR resource for questions and concerns that arise during the year, by being our genealogy resource for new prospective members, by sharing historical overviews of the flags flown during the American Revolution during our monthly meetings, and by actively participating and promoting the School Guard and Color Guard programs.

Neil Elvick who edits our Chapter's newsletter, *The Courier* and has brought the quality of this publication to a high level. His idea of publishing biographies of our patriot ancestors has been hugely successful and helps us understand the sacrifices that our ancestors made. In addition, it has been a way to discover common linkages among our members. For instance, in early 1776, the State of Pennsylvania formed two rifle battalions and one musketry battalion. These three units first saw combat during the battle of Long Island, August 27th, 1776. Neil's ancestor, Jacob Bickel, served in one of the rifle battalions, and President Anderson's ancestor, Patrick Anderson, served in the Musketry Battalion during this battle. Neil also maintains a great website of his family history at neilelvick.com.

Don Spradling who is the Sacramento Chapter's Photographer, Guardian of the Flags, and Sergeant at Arms. The quality of Don's photographs is remarkable and they are a valuable addition to our publications.

President Anderson presented Jim Faulkinbury, Neil Elvick, with Certificates of Appreciation, and Don Spradling was presented with the Bronze Roger Sherman Medal.

Don Littlefield asked to be recognized and presented President Craig Anderson with a Limited Edition Challenge Coin and a Certificate of Appreciation for being last year's president.

Dinner was served.

After dinner Alan Brooking asked to be recognized and presented Craig Anderson with an approved Supplemental Application for an ancestor who was involved in the Revolutionary War.

Past President Russ Kaiser and current Color Guard Commander was introduced as our guest speaker. Color Guard Commander Kaiser wanted members to know more about the Color Guard and the School Guard and would like to get more members involved with these activities. He and several members of the Color Guard were in period clothes and he pointed out how different uniforms were during the Revolutionary War. Each colony wore different colored uniforms. He went over the different parts of a uniform and where you can buy them. He pointed out how many colonists just wore civilian clothes as militiamen and how a member could put together a militia uniform by buying a hunting frock for about \$120, pants for \$100 (or make your own out of a pair of Dockers) a Tricorn hat for \$50 and stockings for about \$15. He went on to explain how you can use a pair of old shoes by adding a buckle.

Commander Kaiser stated that many Color Guard Members go on to have a second uniform and if you buy things correctly you can interchange them. For example, shoes, pants, tricorn hat and shirt can work for militia or Continental uniform if purchased correctly. To have a Continental uniform would mean buying a vest (\$110), and Continental coat (instead of the hunting frock) for \$350 and up. He encouraged members to contact him or other Color Guard members before buying items to let them help you maximize your benefits. He also distributed a handout with information on clothes and where to buy them.

Next commander Kaiser pointed out that you would need a rifle or you could borrow one from the chapter. He demonstrated the difference between a replica that does not fire (about \$200) and a reproduction rifle that does fire (\$700 up).

Commander Kaiser then demonstrated a number of close order drills with his rifle which was enjoyed by all. He said the chapter needs at least 4-6 more members in the Color Guard and 4-6 more members in School Guard. We now turn down requests because we don't have enough members participating.

His presentation was enjoyed by all and President Anderson presented him with a Limited Edition Challenge Coin and Certificate of Appreciation.

Patriot Ancestor

Captain Daniel Wooldridge

Patriot Ancestor of Evan Griffin Jonas #57097

Cpt. Daniel Wooldridge, b. ca. 1758, d. Chesterfield Co. VA 1821, md. (1st) there Nov. 15, 1782, Ann Grant Spencer, (b. Feb. 15, 1767, d. ca. 1789, (2nd) Amelia Co. VA July 25, 1791, Agnes Osborne (will of Margaret Jones in Amelia mentions niece Agness Wooldridge); (3rd) by Rev. Thomas Anderson in Chesterfield May 24, 1814 to Mrs. Sarah Hill (d. 1835; widow of Robert Hill). For the first marriage, Ann's guardian, John Bott or Batt, consented, and Nicholas Robertson, who married Daniel's sister Mary was on the bond. Ann was the daughter of Richard Spencer, merchant at Petersburg, and Elizabeth Pigg, daughter of John Pigg of Cumberland and Chesterfield. (Identification is from 1960 notes sent to Laurence B. Gardiner by Mrs. V. H. Gottschalk Sr. of Washington D.C., who said her brother the late Judge Edwin Cox of Chesterfield Co. compiled them— "Judge Cox lived with his grandfather [391] Daniel [Spencer] Wooldridge after his father went to MO.")

Daniel was willed his father's land in Chesterfield on Thomas's death in 1762, and was the only one of Thomas's sons to settle there. Richard Parker, then Francis Cheatham, then Daniel's brother John [21] Wooldridge, then Daniel's brother Thomas [25] Wooldridge successively served as his guardians. Parker was his brother-in-law, husband of [22] Frances. Cheatham may have been related (via the Osbornes) to Daniel's grandmother, or (via the Hatchers) to his mother. Parker's 1764 account includes an item for repair of Daniel's leather britches, and Cheatham's in 1767 includes a charge for four months' schooling.

According to his Revolutionary War jacket records in the National Archives, he enlisted in July 1777 [he was about 19 years old] for three years and was a private in Captain William Cunningham's Company in the First Virginia Regiment commanded by Colonel John Hendricks (after March 1778, Richard Parker). From May 1779, he was in Captain Charles Pelham's Company of the First Virginia Regiment commanded by Colonel William Davies. Muster rolls show he was present monthly from October 1777 to March 1778, when he was sick in the hospital; April 1778, sick at Valley Forge. On guard duty May 1778, and again in the hospital at Valley Forge in June and July 1778. In August 1778 he was at White Plains, but [pay] for June, July and August 1778 was deducted on account of his "being sick and absent." From January 1779 monthly through April he was at Camp Middlebrook, then at Smith's Cove in April and in June. In July 1779 he was promoted to Captain at Smith Cove; he was back at Camp Rammaporigh (?) in September, then in Camp Haverstraw in October and November. In January 1780 he was in Philadelphia, and was ordered to be discharged by the Board of War on February 29 [leap day!].

On December 5, 1783 major Charles Pelham certified that Daniel Wooldridge had enlisted for three years from February 1, 1777 to February 1, 1780. Samuel Coleman certified in "Council Chamber" on August 18, 1797, that Daniel Wooldridge was entitled to the proportion of land allowed a private of the Continental line in the 1st Virginia Regiment for three years' service, James Wood witness. "Agreeable to the above certificate," James Smith receipted in Daniel Wooldridge's name for a warrant for 100 acres Bounty Land Warrant file, Library of Virginia.

While many family members helped in the Revolutionary cause, Daniel Wooldridge's three years of active service, survival through Valley Forge, and promotion to Captain make his contribution exceptionally distinguished.

Instructions for Submitting Patriot Biographies

Patriot biographies, such as the one above, are being solicited by the national organization. This current one, which appears above, is the one of the last ones which were received from this chapter. SAR is still accepting new ones, so there is still an opportunity for you to submit a biography. To submit your patriot ancestor biography to the national organization submit about 500 words as a Microsoft email attachment to patriotbios@sar.org. Include your name, Chapter and SAR Member number. If you have this type of information about your ancestor but have had difficulty in putting this in narrative form you can receive assistance with this by contacting me at neile@aol.com or to Craig Anderson (craig@winfirst.com). If you have a patriot number assigned, include it with your submission. If not one will be assigned. These biographies are published by the national organization for the purpose of helping aspiring members in their quest to find their own patriot ancestor.
