President's Corner Sept. 2017**Presidents Message**

While we have accomplished a great deal in the past, our chapter still faces some challenges: namely, retaining existing membership, acquiring new members, and encouraging new members to participate in the various chapter programs and activities that have made us successful. In 2017, we started the year with 164 members. We begin 2018 with 181 members. That's terrific! Our great member support is our strength and it permits us to participate in so many of the SAR youth programs.

We have a new Secretary this year, Michael Brady, who chaired our Calling Committee last year. Phil Noble has once again stepped up and taken the job of Calling Committee Chairman. Joe Moorehead will replace Will Gunter on the Calling Committee. Jim Faulkinbury will continue as Registrar and Genealogist. Jim is always anxious to give guidance and support to folks wanting to become members. Carl Ahlberg has our Meeting Speakers almost set in stone for the rest of the year. One of our most immediate needs is for a member to become our Guardian of the Flags. This individual should expect to attend nearly every meeting and bring the United States flag and the California State flag, including flag stands, to each meeting. After more than 15 years, Don Spradling, and his mom Donna, have asked to give this role up.

On January 20 we secured General Liability Insurance for the Sacramento Chapter. That came at a cost of \$739.00 for the next 12 months. We also investigated Reenactors Liability Insurance that would cover our Chapter and our Color Guard members when participating in Color Guard events, including musket firing, however that cost is prohibitive at \$1,707.00 annually. We will revisit that insurance again should a significant number of new members join the Color Guard and show an interest in firing their muskets.

One final item of importance is that the California Society just released a long awaited legal opinion relating to California Assembly Bill 424 relating to Firearms on School Grounds. Based on the advice of counsel, and the California Education Code for Student Discipline, we are removing all muskets, swords, tomahawks and knives, including stage props of these items from our School Guard, Poster Contest, Eagle Scout Courts of Honor, and JROTC presentations, that occur on School grounds. We will continue to work this issue and hope by next school year these artifacts of Americas struggle for independence can again be part of our school presentations.

If you can ride a bike, drive a car, or catch a cab, I hope you will make every effort to try and attend our February meeting. As I noted earlier, if we put forth the effort and persist in our duty, we can prevail. I look forward to seeing each of you on Friday, February 16th.

Minutes from January 2018 Meeting

Sons of the American Revolution – Sacramento Chapter Minutes Sacramento Chapter Meeting, January 19, 2017 Minutes Sacramento Chapter Meeting, January 19, 2018

Sacramento President Don Littlefield called the meeting to order at 7:00. Will Gunter lead the Pledge of Allegiance and President Littlefield gave the invocation followed by Russ Kaiser who led the pledge to the SAR. President Littlefield then gave a brief description of the organization of the Sons of the American Revolution, its membership, and its goals and objectives, and how the Sacramento Chapter supports those goals.

President Littlefield next introduced the National and State Officers and Sacramento Past Presidents who were present. They included California SAR Executive Vice-President Derek Brown and his wife Janet, who is a member of the California SAR Ladies Auxiliary; Past Presidents of the Sacramento Chapter Tom Chilton, Jim Faulkinbury who is also Past President of the California SAR, Russ Kaiser, and Craig Anderson who is also the California SAR State Secretary. He then welcomed Jeff Doyle, Past President of the Mother Lode Chapter who has now transferred to our chapter and is leading the Americanism Poster Contest as Chairman. Also recognized were the other key members to help the Chapter carry out its mission: Carl Ahlberg, Michael Brady, Neil Elvick, Roy Adkins, Don Spradling, Phil Noble, and Joe Moorehead. He also welcomed back Don Clark who has been absent for a few months due to health issues. Next, the members of the DAR present were introduced including Karen Faulkinbury of the Gold Trail Chapter, Marilyn Chilton of the Sacramento Chapter, and Anne Taylor (Regent), Carol Olney (1st Vice Regent), and Ruth Edmondson-Johnson (Registrar) of the Sierra Amador Chapter. Finally, the new members to be inducted this evening were introduced. They were: Brian Charter with his father, Wilbur, and son Philip; George Perrin, and Steve Sanford with his father Don.

The first order of business was the election of the Chapter's officers for 2018. The nominees were Don Littlefield for President and Treasurer, Carl Ahlberg for Vice President Programs, Michael Brady for Secretary, and Jim Faulkinbury for Registrar. There being no nominations from the floor, the membership voted unanimously for the slate of nominees to be our 2018 officers. California Executive Vice President Derek Brown then swore in the new Chapter officers.

Following the installation of officers, the six new members, Brian, Wilbur, and Philip Charter, George Perrin, and Don and Steve Sanford were inducted into the Chapter. Their bios were read to the membership by Registrar Jim Faulkinbury, President Littlefield gave them the oath to the SAR, and the membership then came forward and welcomed each member with the usual handshake.

Next, President Littlefield made announcements that 1) Alan Brooking is in recovery for the next few months, 2) Boys Scouts of American Youth Protection Training is required of any member who is involved in our programs with any youth under the age of 18, including Eagle Scout, JROTC, Color Guard, School Guard, and the Americanism Poster Contest, and that the online course should be taken and the certificate of completion sent to the Chapter Secretary, 3) the chapter has acquired General Liability, D&O insurance, and Property insurance coverage and is still investigating the cost and value of blackpowder/reinactors/firing insurance for those members who would fire their muskets in chapter activities. He also made a pitch for the members to consider putting a uniform together to join our Color Guard which is the face of the SAR to the public. Mention of the upcoming Sacramento County National History Day competition at Inderkum High School on March 3rd and the need for volunteer judges was also made. Executive Vice President Derek Brown then made a pitch for members to attend the California SAR State Meeting in Concord on April 19-21, 2018.

The raffle was then conducted. Those providing raffle prizes were: Will Gunter, Jim & Karen Faulkinbury, Evan Jonas, Russ and Donna Kaiser, Jim Warrick, Ernie & Helen Garcia, Craig & Sandra Anderson, Chris Johnson, and Tom & Marilyn Chilton. Following the raffle, dinner was served.

Following dinner, President Littlefield called the meeting back to order and gave brief remarks about the (continued on following page)

importance of volunteering to support the SAR. He then called Color Guard Commander, Russ Kaiser, to come forward. Russ talked briefly about the activities of the Sacramento Chapter Color Guard during 2017. Stephen DeForest Sanford was born in Corvallis, Oregon on November 18th, 1949 and he currently lives in Citrus Heights. He is a graduate of Virginia Tech and is retired from Architecture in the field of Educational Facilities Design. He served in the USAF from 1969-1976 in Air-to-Ground nuclear missiles. 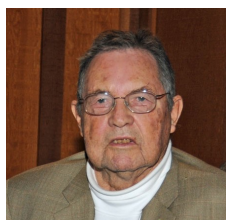

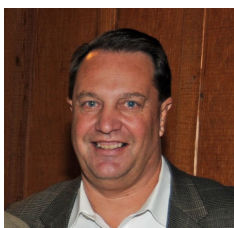

He also served in the 21st Connecticut Militia at the battle of Rhode Island. His father, John Charter Sr., was 1st. Lt. of the 6th Company, 2nd Battalion of Gen. Wadsworth's Brigade, 1st. Conn. Regiment where he served on the Brooklyn Front during the battle of Long Island on August 27th, 1776.

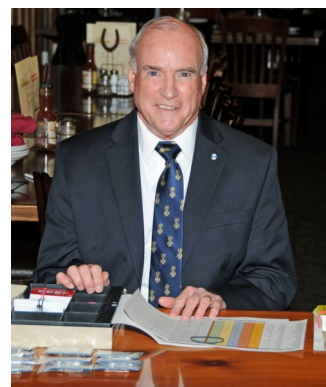

Firearms and the School Guard

AB-424 Possession of a firearm in a school zone.

On October 14, 2017, the California Legislature adopted and Governor Brown signed Assembly Bill No. 424 Possession of a firearm in a school zone. We have been reviewing AB 424 for the past year, seeking opinions from Law Enforcement, California Assembly members, and School Boards. We have also received a legal opinion from The California Society Chancellor, John Dodd, dated Friday, February 2, 2018. [View the California Society legal opinion.](#)

We all know that California schools are generally opposed to items being brought on campus that are, look like, or vaguely resemble, guns, firearms, swords, knives, or other weapons of any kind. Your Sacramento Chapter Officers have come to the conclusion that our best option is to acknowledge and align our presentations with these school policies.

Until it is clear that our Revolutionary War muskets and other weapons are exempt from AB 424, we cannot place ourselves, the Sacramento Chapter, the California Society, or the National Society at risk of a law suit or even an incident by bringing the above listed items, real or props, onto school grounds.

This is not about school administrators or the teachers. It is about risk avoidance of a member of the public or a parent of a child seeing an SAR member or group with muskets or other reproduction weapons in hand, triggering a law enforcement action and felony charges. Keep in mind, these are elementary schools that house 100's of K thru 5 children. It may be more likely that the parents of the youngest kids would be the ones most likely to pull the alarm.

Fifth Grade students who are interested in weapons used in the Revolutionary War can learn more about them from the Internet. There is no mandate that they learn about these items from the SAR. We are simply going against the grain if we persist in including these items. More importantly, we do not want the Sacramento Chapter to be the entity that brings notoriety and bad press to the California or National Societies. Recovery from such events is a long and arduous road if you recover at all.

There are plenty of Revolutionary War and Colonial America topics we can talk about in our School Guard and Poster Contest presentations that will be educational without bringing and including these items of weaponry in our talks.

We will continue to work this issue and hope by next school year these artifacts of America's struggle for independence can again be part of our school presentations.
